Editors

Melvin J. Dubnick is Professor of Political Science at the University of New Hampshire and Professor Emeritus of Political Science and Public Administration at Rutgers University-Newark. He served as managing editor of *Public Administration Review* from 1991–1996 and co-editor in chief of the *Policy Studies Journal* from 1985–1990. In 2003–2005 he held senior research fellowships at the Institute of Governance at Queen's University, Belfast, and has also served in faculty and adjunct appointments at the University of Kansas, Baruch College/CUNY, Columbia University, and the University of Oklahoma. The author of numerous articles on accountability, he has also co-authored textbooks on American government, public administration, and policy analysis.

H. George Frederickson is the Edwin O. Stene Distinguished Professor of Public Administration at the University of Kansas. In 2003–2004 he served as the Winant Visiting Professor of American Government at the University of Oxford, and as a Fellow of Balliol College, Oxford. He is the author of *The Spirit of Public Administration* and *Social Equity and Public Administration: Origin, Developments and Applications*. He is a co-author of both *The Public Administration Theory Primer* and *The Adapted City: Institutional Dynamics and Structural Change*. He is the editor-in-chief of the *Journal of Public Administration Research and Theory*. He received the John Gaus Lecturer Award from the American Political Science Association in 1999.

Contributors

Mark Bovens is professor of public administration and research director at the Utrecht University School of Governance, and adjunct professor at the Australian National University. His research interests include public accountability, success and failure of public governance, democracy and citizenship, and political trust. He has published approximately 15 monographs and edited volumes in the area of politics, government, and legal theory. His present research interests include accountability and governance, citizenship and democracy in the information society, success and failure of public governance, and trust in government. He is a member of the Royal Dutch Academy of Sciences.

Trevor L. Brown is associate professor and associate director for academic affairs and research at the John Glenn School of Public Affairs at the Ohio State University. He teaches courses on public management, public sector strategy, and organizational theory. His research examines why governments elect to make some goods and services internally, while contracting for others. When governments elect to contract, Dr. Brown's research has examined the investments governments make in contract management capacity to deliver desired outcomes. This research has been published in such journals as *Public Administration Review*, *Journal of Public Administration Research and Theory*, and *Journal of Policy Analysis and Management*.

Richard K. Ghere is associate professor of political science at the University of Dayton and is a core instructor in the Master of Public Administration Program there. He is an author of articles on public-sector ethics and private-public partnerships and is coeditor of *Ethics in Public Management* (M.E. Sharpe, 2005).

Christopher Hood is Gladstone Professor of Government and Fellow of All Souls College Oxford, and a Fellow of the British Academy and Academician of the Academy of Learned Societies of the Social Sciences. He specializes in the study of executive government, regulation and public-sector reform. In the past he held chairs at the London School of Economics, the University of Sydney, NSW, and worked at the universities of Glasgow, York, Bielefeld, the National University of Singapore and the City University of Hong Kong. His publications include *The Limits of Administration* (1976), *The Tools of Government* (1983) (updated as *The Tools of Government in the Digital Age* [2007] with Helen Margetts) and *The Art of the State* (1998 and 2000) for which he was awarded the Political Studies Association's Mackenzie Book Prize in 2000. He is the recipient of numerous other honors, including the Public Management Research Association's H. George Frederickson Award for Career Contributions to Public Management Research. In 2008, a prize for political theory at the University of Sydney was named in his honor. In February 2010, Professor Hood presented "Risk and Government: The architectonics of blame-avoidance" as part of the Darwin College Lecture Series.

Bonnie J. Johnson is assistant professor in the urban planning department at the University of Kansas. She teaches planning theory, land use, and politics and planning courses. Research interests include how planners communicate, civic bureaucracy, and sustainability. Before getting her doctorate, Professor Johnson was a practicing city planner for eight years.

Sara Jordan is assistant professor of politics and public administration at the University of Hong Kong. Her major research interests include: the intersections between normative theories of politics and public administration theory and practice, the administrative thought of Continental political philosophers (specifically Jürgen Habermas) and modern American political thinkers (specifically John Dewey), and the tension between liberal democratic theories of politics and emerging problems in healthcare research and practice. Her work appears in *Public Administration*, *Review of Policy Research*, and *Administrative Theory and Praxis (ATP)*.

Margaret P. Karns is professor emerita of political science at the University of Dayton and its first director of the University's Center for International Programs. She specializes in international politics and organizations, with a particular emphasis on U.S. foreign policy and multilateral institutions. She has coauthored three books: *The United States and Multilateral Institutions: Patterns of Instrumentality and Influence* (1990), *The United Nations in the Post-Cold War Era*, 3d ed. (2006), and *International Organizations: The Politics and Processes of Global Governance*, 2d ed. (2010), as well as numerous articles on UN peacekeeping, global governance, and the future of the UN system. Professor Karns is a past vice president of International Studies Association, a member of the Council on Foreign Relations, and a long-time board member and past president of the Dayton Council on World Affairs.

Kevin Kearns is professor at the Graduate School of Public and International Affairs at the University of Pittsburgh. He has published widely on nonprofit managers including accountability in nonprofits, strategic planning, board development, and general management. He is the author

of *Private Sector Strategies for Social Sector Success*, which was honored with the Best Book Award by the Alliance for Nonprofit Management. Dr. Kearns has held a variety of leadership positions in higher education and philanthropy, including serving on the boards of directors of numerous nonprofit organizations and as president of The Forbes Funds, an organization devoted to capacity-building in nonprofit organizations.

Jonathan Koppell holds the Lattie & Elva Coor presidential chair at Arizona State University and is director of the School of Public Affairs. He is former director of the Millstein Center for Corporate Governance and Performance at Yale University. His research concerns the design and administration of complex organizations, particularly entities that hover at the intersection of politics and markets. He has examined global governance organizations that promulgate international rules as well as public-private hybrid entities that operate in the marketplace to achieve public policy goals. He is the author of *The Politics of Quasi-Government: Hybrid Organizations and the Dynamics of Bureaucratic Control* (2003), and *World Rule: Accountability, Legitimacy, and the Design of Global Governance* (2010).

Nicholas Lovrich has been director of the division of governmental studies and services at Washington State University since 1977. Lovrich holds the rank of regents professor in the department of political science and criminal justice program, and the honor of a Claudius O. and Mary W. Johnson Distinguished Professorship in Political Science.

Justin O'Brien is professor of law at the University of New South Wales. He specializes in the dynamics of financial regulation and capital market governance. The author of a trilogy of books on regulatory politics (*Wall Street on Trial* [2003]; *Redesigning Financial Regulation* [2007]; and *Engineering a Financial Bloodbath* [2009]) and has edited volumes on corporate governance, including *The Future of Financial Regulation* (2010).

Ciarán O'Kelly is coordinator of the LLM corporate governance program and lecturer in law at the Institute of Governance, Queen's University, Belfast. His research focuses on the ethics of public administration, corporate governance in the regulatory state, and the politics of identity in divided societies.

John C. Pierce is research associate and affiliate faculty in the public administration department at the University of Kansas and research professor in political science at Washington State University at Vancouver. Pierce is the author or coauthor of numerous books and journal articles on American politics and political culture.

Christopher Pollitt is research professor of public management at the Public Management Institute, Katholieke Universiteit Leuven. Previously he has held full professorships at Erasmus Universiteit Rotterdam and Brunel University (UK). Author of more than a dozen book and 60 articles in scientific journals, his most recent works are *Time, Policy, Management: Governing with the Past* (Oxford University Press, 2008) and *Continuity and Change in Public Policy and Management* (Edward Elgar, 2009). Christopher was president of the European Evaluation Society, 1996–98 and scientific director of the Netherlands Institute of Government, 2004–2006. He has also worked in advisory roles for the World Bank, OECD, European Commission, Finnish Ministry of Finance, Danish Top Executive's Forum and several UK central government bodies.

Paul L. Posner is the director of the public administration program at George Mason University, chair of the Federal Systems Panel of the National Academy of Public Administration, and former president of the American Society for Public Administration. The author of numerous articles on budgeting and federalism, his book, *The Politics of Unfunded Mandates*, received the award for best book on federalism from the American Political Science Association. Before his current position, he was with the GAO, serving as managing director for federal budgeting and intergovernmental management.

Matthew Potoski is a professor in the department of political science at Iowa State University where he teaches courses on public management and policy. He has received Iowa State University LAS awards for Early and Mid-Career Achievement in Research. He is coeditor of *Journal of Policy Analysis and Management* and *International Public Management Journal*. His research investigates public management and policy in domestic and international contexts, including public sector contracting and service delivery, environmental policy, and voluntary regulations. He is coauthor with Aseem Prakash of *The Voluntary Environmentalists* and coeditor of *Voluntary Programs: A Club Theory Approach*. He is author or coauthor of over 30 articles appearing in journals such as the *American Journal of Political Science*, *Journal of Policy Analysis and Management*, and *Public Administration Review*.

Aseem Prakash is the Walker Family professor for the arts and sciences at the University of Washington-Seattle. His research examines core issues in the study of governance, especially the complex relationship of businesses with governments and nongovernmental organizations. He has published over forty articles in refereed journals including *The American Political Science Review*, *The American Journal of Political Science*, *The Journal of Politics*, *World Politics*, *International Studies Quarterly*, *Journal of Policy Analysis and Management*, *J-PART*, and *Public Administration Review*. He is the author of *Greening the Firm*, coauthor of *The Voluntary Environmentalists* (, and the coeditor of *Advocacy Organizations and Collective Action*, *Voluntary Regulations of NGOs and Nonprofits: An Accountability Club Framework* , *Voluntary Programs: A Club Theory Perspective* (The MIT Press, 2009), *Coping with Globalization*, *Responding to Globalization*, and *Globalization and Governance* .

Beryl A. Radin is scholar in residence in the department of public administration and policy at American University. She has published both books and articles that deal with federal management issues, particularly performance measurement and intergovernmental relations. She was the recipient of the 2009 H. George Frederickson Award for Career Contributions to Public Management Research, and is a fellow of the National Academy of Public Administration.

Barbara S. Romzek is professor of public administration at the University of Kansas and interim vice provost for academic affairs. She has published three books and scores of research articles and book chapters on public management, with an emphasis on accountability, government reform, and contracting. Dr. Romzek is a fellow of the National Academy of Public Administration and has received research awards from the American Society for Public Administration and the American Political Science Association. She currently serves on the board of the Public Management Research Association.

Thomas Schillemans is assistant professor at the Utrecht School of Governance, Utrecht University. He received his PhD with honor in 2007 for his thesis on “horizontal accountability in the

shadow of hierarchy.” He has published substantially on accountability in a context of changing governance structures, executive agencies, social policy and the role of the media.

Robert Schwartz is director of evaluation and monitoring for the Ontario Tobacco Research Unit and associate professor at the University of Toronto. He has extensive training in public policy and administration, program evaluation, public oversight, and state audit. In recent years, he was a tenured faculty member at the University of Haifa where he was involved as an auditor and evaluator in many international projects, most recently as a performance monitoring and evaluation consultant for the World Bank. From 1987–97, he worked in the state comptroller’s office in Israel, serving as their expert in program evaluation. In addition to his work on public health policy, his research focuses on accountability mechanisms, performance measurement, balanced scorecards, and program evaluation. He has published in a wide range of journals, including *J-PART*, *Public Money and Management*, *Public Integrity*, *Canadian Public Administration*, and *Journal of Public Policy*.

Timothy J. Shaffer is a graduate of the MPA program at the University of Dayton and is currently a PhD student in adult and extension education at Cornell University. His research focuses on civic engagement, democratic theory, and ways that professionals and citizens engage in collaborative public work.

David M. Van Slyke is an associate professor of public administration and senior research associate in the Campbell Public Affairs Institute at Syracuse University’s Maxwell School. A recipient of the best article award from the *Journal of Public Administration Research and Theory*, his research has also appeared in *Public Administration Review* and *Organization Science*. His work focuses on government contracting, public-private partnerships, strategic management, government-business relations, and policy instruments.

Sally Wheeler is professor and director of Queen’s University, Belfast’s Institute of Governance. Currently serving as chair of the Socio-legal Studies Association, she is a noted specialist on company and corporate governance in the UK and has held chairs in the law faculty at the University of Leeds and at Birkbeck College, University of London. She joined the law school at Queen’s University as chair of law, business, and society in 2004.

Kaifeng Yang is associate professor and MPA director at Florida State University’s Askew School. His research and teaching interests are in public and strategic management, organizational theory and behavior, performance measurement, and e-government. He holds PhD degrees in both business administration (Renmin University) and public administration (Rutgers-Newark), and has engaged in consulting for a number of international companies on strategic management and organizational change. He is a senior research associate of the National Center for Public Productivity at Rutgers-Newark, and a research affiliate of the DeVoe Moore Center at FSU. His work has appeared in *J-PART*, *Public Administration Review*, and *Public Performance & Management Review*.
